This document provides you with key information about this investment product. It is not marketing material. The information is required by law regarding the key information documents related to this product to help you understand the nature, risks, costs potential gains and losses of this product and to help you compare it with other products.

## What is this product?

### Type

The Fund is a form of Collective investment in transferable securities ("UCITS"), as defined by the provisions of Law 4099/2012 and the Directive 2009/65/EC as applicable. The Fund has no legal form, constitutes a group of assets that is composed of securities, money market instruments and cash, the individual elements of which belong to more than one unitholder, based on the number of units they own, is managed by the Company which represents the unitholders both judicially and extrajudicially, for legal relationships arising from the management and their rights over its assets.

### Term

The Fund has an indefinite duration and is terminated in case any of the conditions referred to in article 9 par. 1 of Law 4099/2012 are met and in accordance with article 11 of the Fund's Regulation.

### Objectives

The Fund's investment objective is to provide total return from income and capital growth over the medium to long term, through exposure to an international balanced portfolio, as well as the permanent protection of 85% of the highest net share price recorded on any valuation day of the Fund's assets since inception. Whenever the Fund's net share price is greater than its previous historical high, the protection level will be set at 85% of the new high net share price.

In order to achieve its objective, the Fund has entered into an OTC derivative contract (hereafter "Swap Contract") to (a) enable the Fund to participate in the performance of an international balanced portfolio and (b) achieve protection of 85% of the highest net asset value per share achieved since inception. Specifically, through the "Swap Contract", the Fund will provide exposure to a balanced portfolio of international equities, bonds and cash (hereafter "Investment Portfolio"). The above exposure shall be achieved through indices, Futures Contracts or Exchange Traded Funds (ETFs). The "Investment Portfolio" is dynamically adjusted by the manager of the Fund as part of an active management and does not follow a benchmark. The counterparty of the "Swap", through an algorithm, allocates the assets between the "Investment Portfolio" and cash (hereafter "Protection Portfolio"), in order to achieve the aforementioned "Protection Level". When the value of the "Investment Portfolio" decreases, due to a downward market trend, the exposure to the "Investment Portfolio" will decrease and the exposure to the "Protection Portfolio" will increase respectively. In certain, less favourable, market conditions where the "Investment Portfolio" is experiencing a negative performance, the Fund's exposure to the "Investment Portfolio" can be reduced to zero ("Cash-Lock Event"), thus ensuring that the "Protection Level" will not be violated. In this case, the "Swap Contract" is terminated, and the Fund will not be able to benefit from a future market recovery. Unitholders will be informed of this event and will be able to redeem their units, taking advantage of the level of protection, until the Company decides to amend the Fund's Regulation or to dissolve it, in accordance with the provisions of the applicable legislation. The counterparty to the "Swap Contract" ensures the "Level of Protection" even in the event that, due to a sudden and sharp daily fall in the markets, the mechanism does not reset the exposure in the "Investment Portfolio" in time.

The Fund may use derivative financial instruments for the purpose of its investment objective and/or hedging risks. The use of derivatives may affect, positively or negatively, its performance.

Income generated by the Fund may be reinvested.

The reference currency of the Fund is EUR.

The counterparties with which the "Swap Contracts" have been concluded shall be obliged to value these contracts on a daily basis.

The investor can subscribe or redeem units of the Fund, where the Fund units are available during business days and hours in Greece according to the opening hours of Alpha Bank branches, unless there is a relevant decision of the Hellenic Capital Market Commission to suspend redemptions.

The "ALPHA MULTI-ASSET PROTECT 85 STRUCTURED FUND" is exposed to market risk arising from fluctuations in the portfolio's market value, attributed to market movements. The Fund is exposed to credit risk arising from the possibility that the obligor might be unable to meet its obligations to a UCITS.

The Fund is exposed to currency risk arising from the exchange rate fluctuations and affecting the valuation of the assets that are traded in a currency other than the Fund's reference currency. The Fund is also exposed to liquidity risk, the risk that may arise, if a position of the Fund's portfolio cannot be liquidated at a limited cost within a reasonable period of time, as a result of which it becomes difficult for the Fund to comply with the obligations to satisfy the redemption requests. 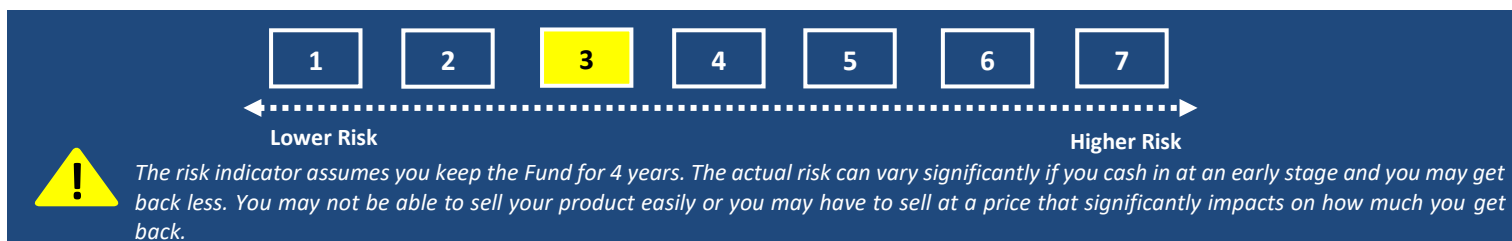
### Intended retail investor

To investors with a mid to long-term investment horizon, four years minimum (recommended holding period) and a moderate investment profile who wish to achieve capital gains and income over a medium to long-term investment horizon, and also enjoy permanent capital protection equal to 85% of the highest NAV achieved since inception.

## What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. On a risk scale 1 to 7, we have classified the Fund at 3 which is a “medium-low” risk class. This classification rates at a “medium-low” level the potential losses from future performance of the Fund and poor market conditions are unlikely to have an impact on the capacity of the Fund, legally represented, to pay you through its Depository. Other relevant risks of the Fund not included in the summary risk indicator are issuer credit risk (the risk of a bond issuer(s) to meet its/their obligations, resulting the Fund to be unable to retrieve part of its investment), counterparty risk arising from the possibility of default of the “Swap Contracts” terms, liquidity risk, the risk that may arise, if a position of the Fund’s portfolio cannot be liquidated at a limited cost within a reasonable period of time, as a result of which it becomes difficult for the Fund to comply with the obligations to satisfy the redemption requests and operational risk, the risk of loss for the Fund that may arise from human errors or omissions, process errors, system failures or external events, including risks related to the custody of the Fund’s assets. The Fund offers permanent capital protection equal to 85% of the highest NAV achieved since inception. However, this protection against future market performance will not apply if there is a credit event either from the issuers of the bonds included in the portfolio or the counterparty to the “Swap Contracts”.

### What happens if the Company is unable to pay out?

### What are the costs?

### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, the holding period and the Fund’s performance. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

### We have assumed

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the Fund performs as shown in the moderate scenario.

### How long should I hold it and can I take money out early?

#### Recommended holding period: 4 years

The Fund has no minimum required holding period. Although there is not a minimum required holding period, it is recommended for investors willing to maintain their investment in the Fund for 4 years (recommended holding period or RHP). This RHP is chosen based on an assessment of the asset mix risk, reward profile and costs of the Fund. You have the option to redeem part or all of your investment, any business day with the respective redemption fee (if any). The redemption of Fund's units is mandatory when requested by the unitholder in accordance with the specific provisions set out in article 7 of the Fund's Regulation.
