## What is this product?

### Type

The Fund is a form of Collective investment in transferable securities (“UCITS”), as defined by the provisions of Law 4099/2012 and the Directive 2009/65/EC as applicable. The Fund has no legal form, constitutes a group of assets that is composed of securities, money market instruments and cash, the individual elements of which belong to more than one unitholder, based on the number of units they own, is managed by the Company which represents the unitholders both judicially and extrajudicially, for legal relationships arising from the management and their rights over its assets.

### Term

The Fund has a term of five (5) years until 2028 and is terminated in case any of the conditions referred to in article 9 par. 1 of Law 4099/2012 are met and in accordance with article 11 of the Fund’s Regulation.

### Objectives

The Fund’s investment objective is to provide income generation and capital gain, while seeking to preserve capital of unitholders who will retain their holdings over the predetermined investment horizon of five (5) years, investing mainly in euro-denominated bonds. In order to achieve its objective, the Fund will invest in a bond portfolio, which will be fully liquidated by December 15, 2028 (hereafter “Maturity Date”). The Fund’s portfolio will have a weighted average maturity (remaining time duration) of approximately five (5) years at the inception, investing in bonds with maturity of three (3) to six (6) years, to be held until their maturity or be liquidated by the Fund’s “Maturity Date”. The bonds in the portfolio maturing before the “Maturity Date” will be replaced by bonds or money market instruments with a maturity as close as possible to the remaining time duration until the “Maturity Date”. The Fund invests primarily in euro-denominated bonds, issued by companies, states and supranational or public institutions, as well as other securities, money market instruments and deposits with credit institutions. The portfolio may include non-investment grade bonds, Greek government bonds, as well as bonds issued by companies with registered office, operations or exposure in Greece.

**Benchmark:** There is no reference to benchmark.

Income generated by the Fund may be reinvested.

The reference currency of the Fund is EUR.

The investor can subscribe or redeem units of the Fund, where the Fund units are available during business days and hours in Greece according to the opening hours of Alpha Bank branches, unless there is a relevant decision of the Hellenic Capital Market Commission to suspend redemptions.

The “ALPHA TARGET MATURITY V 2028 BOND FUND” is exposed to market risk arising from fluctuations in the portfolio’s market value, attributed to market movements. The Fund is exposed to credit risk arising from the possibility that the obligor might be unable to meet its obligations to a UCITS. The Fund is also exposed to liquidity risk, that is the risk that may arise, if a position of the Fund’s portfolio cannot be liquidated at a limited cost within a reasonable period of time, as a result of which it becomes difficult for the Fund to comply with the obligations to satisfy the redemption requests. In more detail, the risks associated with the Fund are presented in the next section “What are the risks and what could I get in return?”

### Intended retail investor

To investors with a long-term investment horizon of five years (recommended holding period) and a balanced investment profile who wish to achieve income and capital appreciation by investing in a Greek-oriented bond portfolio, which will be fully liquidated by December 15, 2028.

## What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. On a risk scale 1 to 7, we have classified the Fund at 2 which is a “low” risk class. This classification rates at a “low” level the potential losses from future performance of the Fund and poor market conditions are very unlikely to have an impact on the capacity of the Fund, legally represented, to pay you through its Depositary. Other relevant risks of the Fund not included in the summary risk indicator are issuer credit risk (the risk of a bond issuer(s) to meet its/their obligations, resulting the Fund to be unable to retrieve part of its investment), liquidity risk, the risk that may arise, if a position of the Fund’s portfolio cannot be liquidated at a limited cost within a reasonable period of time, as a result of which it becomes difficult for the Fund to comply with the obligations to satisfy the redemption requests and operational risk, the risk of loss for the Fund that may arise from human errors or omissions, process errors, system failures or external events, including risks related to the custody of the Fund’s assets. The Fund does not include any protection from future market performance so you could lose some or all of your investment.

### Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

### What are the costs?

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, the holding period and the Fund’s performance. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

#### We have assumed

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the Fund performs as shown in the moderate scenario
- 10.000 EUR is invested.

### How long should I hold it and can I take money out early?

#### Recommended holding period: 5 years

The Fund has no minimum required holding period. Although there is not a minimum required holding period, it is recommended for investors willing to maintain their investment in the Fund for 5 years (recommended holding period or RHP). This RHP is chosen based on an assessment of the asset mix risk, reward profile and costs of the Fund. You have the option to redeem part or all of your investment, any business day with the respective redemption fee (if any). The redemption of Fund's units is mandatory when requested by the unitholder in accordance with the specific provisions set out in article 7 of the Fund's Regulation.
